AGREEMENT

I, _____
Hereinafter called the Delegate

residing at (address) _____

wish to participate as a Delegate in the final of 'Model Search Gibraltar 2009' to be organised by Mount Productions (hereinafter referred to as the Organiser).

In consideration of your accepting my aforesaid participation, I hereby agree to be bound by the terms and conditions stated in this document (hereinafter called the Agreement).

1. I understand that to be eligible to participate as a Delegate in the Contest, I:
 - a. Must hold a passport indicating British or Gibraltarian Nationality or be a fulltime resident.
 - b. Shall have attained the age of 18 years by 1st June 2010 or be not older than 30 years on or before 31st December 2010 if male, or 26 years on or before 31st December 2010 if female.

- c. Must be co-operative and willing to abide by the directions and advice given by the authorised personnel of the Organiser.
- d. Must be a person whose background or character is not likely to bring into disrepute the Contest, Sponsors, the Organiser or any person associated with them.
- e. Must have no tattoos unless they are either in a place, which cannot be seen when wearing swimwear, or can be hidden with cosmetics.

2. I hereby declare that:

- a. I have satisfied each and every requirement of eligibility set out in Clauses 1(a), 1(b), 1(d) and 1(e) above. I shall satisfy the requirements set out in Clause 1(c) hereof.
- b. All the information supplied by me in the general information form is true and accurate.

3. I understand that:

- a. The Contest shall be held in Gibraltar on 30th July 2009 and I hereby undertake to attend all rehearsals and related activities on time and in good spirits. Rehearsals take place in the early evening.
- b. The Organiser may designate such clothing, footwear and accessories for use during the Contest and/or for the purposes of the Contest in which event the Organiser shall have absolute and unfettered discretion in the choice thereof and I hereby undertake to accept whatever may have been so designated.
- c. Once I have signed the Agreement I have only 5 days in which to cancel. Any attempt to do so after this period will result in a penalty of £150 plus any related expenses incurred by the Organiser in relation to my participation. This includes legal fees if the Agreement needs to be enforced.
- d. The Organiser at his discretion may decide to extend the closing date for application.
- e. Height restrictions may mean that participation in World Finals may be limited. Mount Productions will attempt to place the winning Delegate in one of a selection of contests within the Year of Office but it may prove to be difficult and participation in the World Final may be offered to the second or third placed Delegate or any person so identified and nominated by the National Director. Mount Productions reserves the right not to send any delegate to World Finals.

4. Further I agree to the following:

- a. Parents, spouse or friends cannot attend rehearsals and control over my activities for the purpose of the Contest shall rest with the Organiser.
- b. I will switch off mobile phones during rehearsals.
- c. I will only smoke during designated breaks.
- d. I will respect the choice of judges and accept the judges' final decision.

- e. Due to unforeseen circumstances the Contest could be postponed or cancelled and the Organiser is not liable for any expenses incurred by me, or on my behalf by any third party or parties.
 - f. The Organiser shall not be liable under any circumstances for any loss or damages sustained by me as a result of or arising out of the exercising by the Organiser of any right or discretion hereunder.
5. I hereby declare and acknowledge that the Organiser shall have the unfettered right and discretion at all times to do any of the following things:
- a. To reject without stating any reason or reasons whatsoever my application to participate in the Contest.
 - b. To withdraw me from the Contest at any stage after offering a verbal warning. As per clause 5(a) above the organiser retains the unfettered right and discretion at all times to withdraw me from the Contest without having to state any reason or reasons whatsoever.
6. I hereby authorise the Organiser to use or to authorise the use of my photographs (whether supplied by me or otherwise) for all publicity and commercial purposes in connection with the Contest. The Organiser shall have exclusive rights and I hereby release any claim that I may have by virtue of my participation in the Contest, or any use of my photographs in connection with such rights, including advertising and promotional material relating to any such exploitation.
7. I hereby warrant and undertake that:
- a. I have not entered and shall not enter into any management agency or sponsorship contract or any contract relating to entertainment advertising or publicity during the period of the Contest.
 - b. I shall not make any personal appearance nor give any interview nor allow publication, in any media, of any article or information concerning the Contest or myself for a period commencing with the date of this Agreement until the conclusion of the Contest without the prior consent of the Organiser.
 - c. I shall not participate in any similar competition until the contest is over without the written consent of the Organiser.
8. I hereby warrant and undertake that if I am elected Winner, I shall as conditions precedent to my election:
- a. Not enter into any competitions for a year upon being nominated Winner (hereinafter referred to as the Year of Office) without prior written consent of the Organiser. I shall also sign a separate agreement with the Organiser, upon winning the title. Should I not sign then I shall forfeit my title and all rights and prizes.

- b. Participate in all activities whether promotional publicity or otherwise wherein the title of Model Search Gibraltar 2009 will be presented or such activities that the Organiser may designate.
 - c. Appoint the Organiser as my exclusive manager and agent at a fee equivalent 25% of all moneys obtained by me in related activities during the Year of Office.
 - d. Be able to travel to the designated World Finals in the year 2009/10 when a date is available or hand over the title and flight ticket to the second placed Delegate or other candidate selected by the Organiser.
 - e. Give advanced notice to Mount Productions each time a period of time is spent away from Gibraltar.
9. If I am in breach of any one of the warranties or undertakings herein contained or if I have made any false undertakings herein contained or if I have made any false declaration in this Agreement, the Organiser may in its absolute discretion:
- a. Deprive me of the title awarded.
 - b. Award the title, prize money and award of prizes to any other Delegate in the Contest, or deal with the title, prize money an/or award of prizes as the Organiser sees fit in its absolute discretion.
10. This Agreement constitutes the entire agreement between the parties and supersedes and previous oral agreement(s) and may not be varied or amended unless the variation or amendment is in writing and signed by the parties hereto.

11. PLEASE READ CAREFULLY

In the event that the parents are divorced or separated or in the event that one of the parents or guardians does not give consent to the Delegate to enter the Contest, the Delegate shall not be allowed to apply for admission in the contest. In the event that the Delegate withdraws from the Contest as a result of lack of parental consent of one of the parents/guardians, the Organiser reserves the right to claim from the delegate any costs of whatsoever nature incurred by the Organisers in respect of, connected with or arising from the Contest.
